CIGNA Wellness Incentive Plan: The CIGNA dental plan is designed to encourage yearly visits to dentists for preventative care. If a covered person obtains Class I services in the prior Calendar Year, the annual maximum progresses to the next level. The increase applies to both in and out of network annual maximums. For example, employee is enrolled in Plan B with a first-year annual maximum of \$1,650, Employee obtains a Class I preventative service in Calendar Year 2021. The employees 2022 Calendar Year max increases to \$1,750.

CIGNA Dental Oral Health Integration Program® offers enhanced dental coverage and more for dental customers with any of the following medical conditions: diabetes, heart disease, stroke, maternity, head and neck cancer radiation, organ transplants and chronic kidney disease.
